Guidelines for the Citizen of the Year:

- 1. Nominees shall be residents of Eastern Clallam County. (Primarily the Sequim School District area).
- 2. Nominees shall be persons who have performed outstanding service to the community.
- 3. An individual or couple cannot be nominated/considered 2 years in a row.
- 4. No one is allowed to nominate more than one candidate.
- 5. Nominations made for Citizen of the Year may NOT be made by an immediate member of the family of the nominee.
- 6. Two written letters of endorsement from individuals other than the nominator MUST accompany the nomination form of endorsement will be considered with the nomination.
- 7. Service rendered by such nominees shall be above, beyond, and generally outside the regular occupation of the nominee.
- 8. Two persons working jointly in a community project or projects may be nominated to receive a joint award. Groups of more than two will not be considered.
- 9. Past "Citizen of the Year" recipient(s) are not eligible.
- 10. Only one COY award will be awarded annually.
- 11. All eligible and complete applications will be evaluated by the committee, and not more than three finalists will be selected.
- 12. The finalists, of which there will be no more than three, will be invited to and recognized at the luncheon.
- 13. Person(s) making nominations(s) should bear in mind that the selection committee is, if necessity, the final determining authority for awards.

Method of Nomination:

Nomination should be presented via a Citizen of the Year nomination form which is available online or at the Sequim-Dungeness Valley Chamber of Commerce Visitor Information Center. Additional pertinent information may be included. Please limit additional information to a one-page presentation.
